STANDING COMMITTEES

EDUCATION: The Education Committee provides guest speakers, demonstrations and networking opportunities. Never endorses products or vendors. Sponsors Educational programs to increase the professional competence of all members.

FINANCE: The Finance Committee serves as the fiscal arm of the Association. It makes recommendations to the Board of Directors regarding all financial activities and requests for non-budgeted items. It prepares the annual operating budget and meets monthly.

GRIEVANCE: The Grievance Committee reviews and investigates complaints by members and the public to determine whether a complaint warrants a formal hearing. Also investigates charges of unethical conduct and presents findings to the Professional Standards Committee for adjudication and possible disciplinary action. All members of the committee must attend the accredited Professional Standards training at least every other year.

LEGISLATIVE: The Legislative committee monitors local governmental activity. Informs membership of all legislative and administrative law issues effecting real estate. Promotes member awareness of city and county ordinances concerning day to day real estate business. Creates lines of communication with elected officials.

MEMBERSHIP: The Membership Committee is responsible for promoting and recruiting REALTOR[®] and Affiliate membership in the Association.

MULTIPLE LISTING SERVICE/TECHNOLOGY: The Multiple Listing Service/Technology Committee is responsible for recommending continued improvements to the MLS. They also recommend to the Board of Directors necessary revisions to MLS Rules and procedures; maintain MLS security and sponsor MLS Meetings to provide marketing and educational data.

PROFESSIONAL STANDARDS: The Professional Standards Committee hears complaints involving arbitration of commissions and alleged breaches of professional conduct under detailed rules. Make money awards in arbitrations. All members of the committee must attend the accredited Professional Standards training at least every other year. Prerequisite for this committee requires that the committee member serve on the Grievance Committee prior to selection.

STRATEGIC PLANNING: The Strategic Planning Committee meets to discuss the future direction of the Association.

SPECIAL COMMITTEES

AFFILIATE: To initiate and provide specific programs, which will be informative, educational and sometimes humorous.

BYLAWS/RULES & REGULATIONS: The committee should meet periodically as need arises for revisions, updates or recommended local changes to the Bylaws. This committee also reviews and updates the recommended rules & regulations changes as requested by any member.
